

Two main consultation phases

Feb – Apr 2018

- Proposed development strategy
- Proposals for new and updated policies

Oct – Dec 2018

- Draft plan
- Site allocation proposals
- Proposed policy designations

Local Plan and National Policy

- Bristol Local Plan makes provision for the protection of open spaces which are important for recreation, leisure and community use, townscape and landscape quality and visual amenity
- The National Planning Policy Framework (NPPF) also introduced a new designation of 'Local Green Space' (LGS)

Purpose of the Local Plan Review is to;

- bring the policy and background evidence up to date;
- introduce LGS designation and;
- identify any undesignated open space that should be protected;
- identify any designated open space that no longer meets criteria.

Proposed approach

- 1. **LOCAL GREEN SPACE** spaces to be protected in perpetuity; development only allowable in very special circumstances.
- 2. **RESERVED OPEN SPACE** spaces retained for their green infrastructure role but subject to regular review through the Local Plan process.

Local Green Space

- NPPF definition;
- Close proximity to the community it serves
- Is local in character
- Is demonstrably special for its;
 - beauty,
 - historic significance,
 - recreational value,
 - tranquillity and
 - richness of wildlife.

Lawrence Weston Neighbourhood Plan introduced Bristol's first Local Green Spaces.

Reserved open space

- Those to which the Local Plan should offer protection from most forms of development but which would be subject to regular review.
- Criteria/assessment indicators for identifying these are broader.
- The key distinctions from Local Green Space are value to the community and their need to be retained in perpetuity.


Examples of types of designation

 - Incidental amenity land


Destination Parks – The Downs



Traditional / Multi-functional Parks – Doncaster Road Park




Town and Village Greens and Common Land – Shirehampton Green




Local Nature Reserves – Callington Road LNR
