35. WELCOME, INTRODUCTIONS AND APOLOGIES FOR ABSENCE

Apologies for absence were received from Lorraine Horgan.

36. MINUTES OF THE MEETING HELD ON 20TH DECEMBER 2011

AGREED-

That the minutes of the meeting held on 20th December 2011 be agreed as a correct record and signed by the Chair.

Matters arising:

- Outline planning permission for development at Imperial Park had now been granted by the Development Control Committee
- The new leisure centre and hospital facility at Imperial Park were now open

37. COUNCILLOR DECLARATIONS OF INTEREST

No interests were declared by councillors.

38. PUBLIC FORUM

Public forum statements were received from Mr Keith Way and from Avon Wildlife Trust, both in relation to the item on Parks and Green Spaces Strategy. It was agreed that they should be considered in conjunction with agenda item No. 7 on that matter.

39. AREA CO-ORDINATOR'S REPORT ON DEVOLVED BUDGETS

The Neighbourhood Partnership considered a report of the Area Co-ordinator (Agenda Item No. 5) detailing progress and providing updates on the devolved budget spend.

During discussion, particular reference was made to:

- Speed limits Councillor Kent explained that the Council was intending, over a 3 year period, to introduce 20 mph speed limits on all residential streets within the built up areas across the city, excluding main arterial roads. He commented that there would be prior consultation with all neighbourhood partnerships about roads to be included in the scheme. Enforcement had been discussed with the Police. It was envisaged that the approach would be an educational one in the early stages as opposed to the immediate issuing of fixed penalty tickets;
- Concerns were expressed that following resurfacing work in Aldwick Avenue, the road had immediately been dug up by a utility company. Officers agreed to investigate why there had been a lack of co-ordination;
- In relation to Clean and Green, some residents felt that the Council's cleansing contractor was not clearing litter effectively, especially from hedgerows and land in the vicinity of ASDA and the airfield. It was agreed that officers should follow up complaints already made and not responded to. It

was proposed that a representative from May Gurney be invited to the next Partnership meeting;

- Pigeonhouse Stream discussion about the lack of agreement between the various parties involved as to the environmental works which should be undertaken and the nature of action eventually taken, which was a compromise and needed to be carried out prior to the bird nesting season;
- Litter bins (page 19 of the agenda). A member of the public explained that a particular problem was people using the bins to dump domestic waste in. Officers to investigate;
- Wilmott Park play area in response to a question from a member of the public it was explained that there would be consultation, and Councillor's Brain and Pickup would be involved in discussions, before a final decision on location was made:
- S106 Transport Budget the Transport Sub-Group were currently considering a range of options for spend, and a report with recommendations would be submitted to the next Partnership meeting;
- S106 libraries a report on spending proposals would come to the next meeting of the Partnership. Libraries at Bishopsworth and Hartcliffe were the ones within the Dundry View area.

AGREED - To note the updates and progress on devolved budget spending.

40. HIGHWAYS DEVOLVED BUDGET REPORT INCLUDING S106 HIGHWAYS BUDGETS

The Neighbourhood Partnership considered a report of the Area Manager, Highways and Traffic, Transport Service, (Agenda Item No. 6) relating to the devolved transport budgets available to the Dundry View Neighbourhood Partnership (NP).

Neil Terry, Area Manager for Highways, Traffic and Transport Service introduced the report.

Local Traffic Schemes

During discussion;

- It was noted that a further report would be brought to the June meeting about the budget and options for new schemes:
- The Transport Sub-Group had agreed that Scheme T1 in the report was to be undertaken through a phased approach spanning several years, using available funding;
- A member of the public expressed concerns about the poor state of repair of the path to Winash Close garages. It was not clear if this was adopted highway. Officers undertook to investigate the legal status of the path and works necessary if Council owned;
- Fulford Road shops care needed to be taken to ensure that the design took account of lines of visibility before any work was committed. Currently parked vehicles obscure pedestrian's view;
- Ilchester Crescent / Aylesbury Crescent temporary boulders had been moved. A more permanent solution was necessary. The Area Manager undertook to investigate.

41. PARKS AND GREEN SPACE STRATEGY – SURPLUS LAND DECISION

The Neighbourhood Partnership considered a report of the Parks & Green Space Strategy Co-ordinator, (Agenda Item No. 7) relating to sites being deemed surplus to requirements.

At the invitation of the meeting, Mr Keith Way and Ms S Parry (on behalf of Avon Wildlife Trust) presented their public forum statements.

The officer discussed the key issues in the report

During discussion, particular reference was made to:

- The proposed incentive scheme and how it would operate. The fact that each site could only be given a category as opposed to a value, did not help the Partnership to gauge what it might receive in terms of money, should it agree to dispose of any sites. As all Dundry View sites were category A or B, the overall receipt was likely to be fairly low, even if a decision were to be taken to dispose of all of them.
- Partners and members of the public discussed why they
 were opposed to the sale of specific pieces of land which
 were identified in the report. There was a general view that
 current green space sites formed natural wildlife corridors
 from Dundry Beacon which would be harmed if
 fragmentation was allowed to occur.

Following further discussion, councillors then:

RESOLVED -

- (1) That none of the following sites are surplus to requirements and should be retained for use as green space for recreation:
 - part of Withywood park (Paybridge Road)
 - Huntingham Road / Keble Avenue
 - Billand Close (Sherrin Way)
 - Part of Willmot Park (North)
 - Part of Willmot Park (South)
 - Part of Valley Walk (North Blackthorn Close)
 - Part of Valley Walk (South rear of Urmstone)
- (2) That the Committee reaffirms Cabinet's decision of December 2010 to declare the following site as not surplus and therefore to be retained for use as green space for recreation:
 - part of Kingshead Park

42. PARKS AND OPEN SPACES – CROX BOTTOM MANAGEMENT PLAN INVESTMENTS

The Neighbourhood Partnership considered a report of the Project Development Officer (Parks), Environment and Leisure (Agenda Item No. 8) concerning proposals for the spend of £15,364.63 of S106 money in order to implement improvements and install items

of park furniture as agreed with the local community for the improvement of Crox Bottom.

The Area Co-ordinator introduced the report and discussed the proposals and the suggestions which had been made by the Pride of Place Group at its recent meeting.

During discussion;

- A member of the public indicated that the Malago Valley Conservation Group was keen to assist in the development of Crox Bottom as an open space and might be willing to contribute to towards some of the work proposed in the report
- The large frontage from Hengrove Way would benefit from a separate design exercise being undertaken
- There was general agreement that signage -in the form of larger "Brissco" entrance signs and smaller parks notice boards should be provided
- The painting of fences, barriers and gate should be undertaken by community payback instead of the parks contractor

Councillors then:

- RESOLVED (1) that the spend of £15,364.63 of \$106 money be approved in order to implement improvements and install items of park furniture as agreed with the local community for the improvement of Crox Bottom contained within the table below, and for the underspend of £1004.43 to contribute
 - (2) that the agreed works be as follows with any items of work not completed from the list being included in the Crox Bottom Management Plan which will also consider longer-term investment requirements:

46. BUS RAPID TRANSIT / SOUTH BRISTOL LINK ROAD

The Neighbourhood Partnership received a verbal report from Alun Owen, the Council's Service Director for Major Projects (agenda item no. 11) relating to the Bus Rapid Transit / South Bristol Link Road scheme.

He discussed the extent of the scheme and circulated a map showing the intended route. He described the arrangements for public consultation, submission of scheme details to Government and the public inquiry arrangements, which would culminate in a build programme from summer 2014 to summer 2016.

Initial consultation sessions so far arranged (with North Somerset Council which is also affected by the project) were as follows :

Long Ashton Village Hall – 9 May (2.00 - 8.00 pm) Gatehouse Centre – 16 May (5.00 – 8.00 pm) Withywood Centre – 22 May (2.00 – 6.00 pm)

AGREED - That a special meeting of the Partnership be arranged to allow for a full discussion of the proposals, and that Heather Williams, (HWCP) liaise with Alun Owen regarding an appropriate date and venue for the session.
