# 1 WELCOME AND INTRODUCTIONS

Councillor Mark Weston, Chair, welcomed all to the meeting and asked for introductions.

# 5. PARKS AND GREEN SPACE STRATEGY SURPLUS LAND DECISION

Councillor Weston welcomed Jennifer Mackley, Strategy Co-ordinator, Neighbourhoods, Bristol City Council, to the meeting on behalf of the Partnership.

Jennifer Mackley introduced the report to the Neighbourhood Partnership (Agenda Item No. 5), setting out the parks and green space strategy surplus land decision.

During consideration of the report the following points were highlighted:

- The Partnership was asked to note the following history to this point:
  - February 2008 Council adopts green space strategy with aspirations to raise the quality of Bristol's parks. The strategy adopted the principle of selling some land to fund this.
  - June October 2010 Area Green Space Plans identify green space that could be declared as surplus. Public consultation is held on proposals;
  - 16 December 2010 Cabinet takes the decision to declare some land as surplus, retain other land as green space and defer on remaining sites until a later date;
  - June November 2011 Cross party working group convenes to review green space strategy aspirations, consultation responses and Dec 2010 Cabinet decision;
  - 22 November 2011 Full Council discusses the cross party working group findings and an all party agreement is made that Neighbourhood Committees should make the final decision on land declared as surplus; and
  - 26 January 2012 Cabinet resolved that Neighbourhood Committees make decisions with regard to land proposed as surplus to parks requirements with a view to potential disposal for development (surplus sites).
- It was also noted that the potential financial outcome of the Neighbourhood Committee's decision would be dependent on an incentive scheme, which had been recommended by the Cross Party Working Group and subsequently adopted by Cabinet. This means that a maximum of 70% of the value of the land, if sold, will only be available to the Partnership if <u>all</u> sites are declared as surplus. The fewer the sites agreed for disposal the lower the percentage of sale value will be made available to the Partnership. The remaining 30% of the land – if sold (minimum) would be held centrally to spend on green space infrastructure;
- The Partnership, whilst noting the funding formula proposals, expressed concern at the reduced sale value if fewer than all sites are released for disposal. They asked that the percentage of sale of <u>any</u> land released for disposal be renegotiated before any final decision on disposal;

- Several members of the public indicated that should any land be sold for development consideration should also be given to the impact on other amenities (health services, education and traffic).
- The Partnership in noting the statement from Christine Rowland, indicated that assistance with the maintenance of any part of the Fonthill Park retained for use by the school to deliver its 'Forest School' activities could be undertaken by 'Southmead Sports'; and
- Members expressed concern at the impact of proposed adjoining land in South Gloucestershire which had been identified as part of their planning proposals for housing development, and the impact that this would should a similar decision be taken by the Neighbourhood Committee.

Councillor Weston outlined his proposals for dealing with each of the sites, individually and giving the option to either retain as open spaces or defer the decision until the May Neighbourhood Partnership meeting to allow time to renegotiate the funding proposals with the cabinet.

The BS10 Planning Group in considering the sites based in the Southmead ward expressed the view that Elderberry Walk, Trym Valley and Embleton Walk be retained as parks and open spaces and also asked for an improved percentage of sale value to be returned to the Partnership, should the sale of Fonthill Park be approved.

Jenny Smith moved:

- (i) That Elderberry Walk, Trym Valley and Embleton Road CPG be retained as Parks and Open Spaces, and
- (ii) That Fonthill Park could be considered for disposal if 70% of the money generated were retained locally, and that a small section of the Park be retained to enable its continued use by Fonthill School to deliver Forest School activities..

This was seconded by Councillor Brenda Massey.

# **RESOLVED** –

# (i) That Elderberry Walk, Trym Valley and Embleton Road CPG be retained as parks and open spaces; and

# (ii) That Fonthill Park could be considered for disposal if 70% of the money generated were retained locally, and that a small section of the Park be retained for continued use to deliver Forest School activities.

Following detailed discussion with the Partnership on the sites based in the Henbury Ward, the Neighbourhood Partnership indicated that they were against the sale of any of the parks and open spaces based in the Brentry or Henbury area. Therefore Councillor Weston moved:

That Arnall Drive (North), Arnall Drive (South), Brentry Hill, part of Crow

Lane, Okebourne Road and Tranmere Avenue all be retained as park and open spaces.

This was seconded by Councillor Brenda Massey

# RESOLVED -

(i) That Arnall Drive (North), Arnall Drive (South), Brentry Hill, part of Crow Lane, Okebourne Road and Tranmere Avenue all be retained as park and open spaces.

#### 6. DEVOLVED SERVICES REPORT

The Neighbourhood Partnership considered a report of the Area Co-ordinator (Agenda Item No. 6) setting out the devolved services report.

Jenny Smith reported that representations had been to the Sustainable Development and Transport Scrutiny Commission, regarding the proposed withdrawal of the No 20 Bus Service. It was anticipated that a statement and petition would be presented to the next meeting of Full Council to be held on 27 March 2012.

The Partnership also noted that there are a number of bus stops without shelters across the NP area – Rectory Gardens was given as an example – and agreed that a 'shopping list' of further sites which need shelters be developed through the Traffic and Transport Sub-Group **Action KH** 

# RESOLVED

- (1) that progress updates on Carriageway Surface dressing and Footways (items 1.1 a and b of the report) and on Minor Traffic Schemes (items 1.2 a, b c and d of the report), in particular the continuing issue of funds to install anti-skid surface at the Aldi crossing in the note at 1.2c be noted;
- (2) that the actions taken on Narrow Estate Roads and Minor Traffic schemes in item 1.2 c and d of the report (picked up in the Devolved Transport Schemes Report, be noted;

- (3) that the progress made in developing the Community Transport scheme in Henbury/Brentry be noted;

#### 7. S106 ALLOCATION TO BARNARD PARK, HENBURY

The Neighbourhood Partnership considered a report of the Area Environment Officer, Environment and Leisure (Agenda Item No. 7) setting out the s106 allocation to Barnard Park, Henbury.

The Recommendation set out in the report was moved by Councillor Weston, seconded by Councillor Massey, and

#### (1) that the s106 spend of £6,589.29 be agreed; and

(2) that the sum of £6,589.29 be allocated to Barnard Park to improve the park for play, provide new benches and herbaceous planting.

#### 8. DEVOLVED TRANSPORT SCHEMES FOR 2012/13

The Neighbourhood Partnership considered a report of the Service Director, Transport Services (Agenda Item No. 8) setting out the devolved transport schemes for 2012/13.

During detailed discussion of the report the following points were highlighted:

- in relation to footway resurfacing, several members from Southmead sought clarification on the process for selecting footways for maintenance work;
- the Partnership agreed that the traffic and transport sub-group would commence the process of looking at the footway priorities for 2013-14;
- In response to a request to address the issue of parking on the pavements at Crow Lane, it was noted that this would be raised with Safer Bristol and the Police and brought back to the Traffic and

Transport sub-group.

- Partnership noted that there is an accumulated underspend of £1449.82 in the Minor Signs and Lines budgets from 2010/11 & 2011/12.
- Added to the 2012/13 Minor Traffic Schemes budget of £17,143 this leaves a total of £18,592 to fund 2012/13 programme of work

Following detailed discussion on the Transport schemes, it was moved by Councillor Massey, and seconded by Jenny Smith, and
