PARKS AND GREEN SPACE STRATEGY - SURPLUS LAND DECISION

The Neighbourhood Partnership received a report of the (Agenda Item No. 6) setting out the parks and green space strategy - surplus land decision.

Richard Fletcher introduced the report and summarised it for everyone.

During the debate that followed it was noted that Hengrove Park had not been included because the decision to develop part of the site pre-dated this strategy.

Following a debate it was

RESOLVED - (i) that none of the sites be sold; and

(ii) that the Cabinet decision of December 2010 to declare part of Craydon Road open Space not surplus be confirmed.

HIGHWAYS DEVOLVED BUDGET REPORT

The Partnership received a report of the Service Director, Transport (Agenda Item No. 7) setting out the highways devolved budget report.

Shaun Taylor introduced the report and summarised it for everyone.

In response a question, Shaun Taylor stated that whilst a small saving could be made by advertising Schemes T 1 and T 7 at the same time, each scheme would still cost the same to implement.

Referring to scheme F 2, Shaun Taylor advised that a planning consent on an adjacent site, involving highway and footway improvements, had recently been approved. Members may therefore wish to defer a decision on this scheme. This was agreed.

Hengrove and Stockwood split their devolved budget exactly in half, with half to spend in each ward.

Following a debate it was

RESOLVED - Local Traffic Schemes

- (i) that Scheme T 1 be agreed;
- (ii) that Scheme T 2 be agreed up to the value of the remaining Hengrove money;
- (iii) that decisions on Schemes 5 and 6 be deferred until the next Meeting of the N P;
- (iv) that Scheme T 7 be agreed;

Footway Resurfacing

- (v) that Scheme F 1 be agreed;
- (vi) that a decision on Scheme F 2 be deferred;
- (vii) that part of Scheme F 3 be agreed;

(It was noted that for financial reasons no decision could be made on Scheme F 4.)

Carriageway Surface Dressing

- (viii) that Scheme C 1 be agreed; and
- (ix) that Scheme C 2 be agreed.
