Background


- Pilot project with Kingdom Environmental Services to tackle environmental enforcement started 6 November 2017
- Longer term contract with 3GS started 5 February 2019

- Over 17,000 Fixed Penalty
 Notices served by contractors
 during the past 22 months





Type of offences

Since 3GS started more action taken against a wider range of offences.

Dog fouling- 2 Fixed Penalty Notices since April

3GS hotspot patrols informed by pooper snooper app and requests from councillors. Maps of operations coming.

Handing out poo bags. Stickers available.

Dog related enforcement

Dogs off leads - 28 Fixed Penalty Notices since April **Public Space Protection Orders** (PSPOs) 2017 offence

A PSPO bans or restricts certain acts or behaviour in a certain area. They're used in areas where certain behaviour is having a negative effect on the quality of life of those using the space.

Littering (non smoking) – 269 £100 FPNs since April **Flytipping** – 16 £400 FPNs/ 5 prosecutions

Byelaws

- Most of Bristol's parks and green spaces are covered by the byelaws for pleasure grounds, public walks and open spaces
- Police and Community Support Officers (PCSOs) and council officers check parks and green spaces. If they see someone breaking a byelaw that person will be asked to stop. If they continue they might be removed from the area and can be fined up to £500.
- Breaking byelaws can be reported on Council's website
