### Castle Park Town Green Application

As expected the Council's Rights of Way and Greens Committee rejected the Castle Park application on a technical legal point on Monday. However, many members of the committee clearly supported the idea of a Town Green designation and they passed a resolution asking the Cabinet to bring forward a voluntary Town Green application. They also suggested that other parks should be given Town Green status as part of the P&GSS.

This is potentially very positive news, but we need to see how it develops.

## Eastville Park Cycle Route

The Eastville Park Action Group have passed on this message:

I am writing to you to ask for your consideration the resurfacing proposals Cycling City has for the Frome Valley route through Eastville Park. Please see plan at <http://www.bristolparksforum.org.uk/EastvilleParkCycle.pdf> . In Summary we are hoping, this financial year to resurface and widen the existing path to 3metres from the Boating Lake to Fat Mans Reach bridge (the very narrow bridge). Section 1 and 2 on the plan. The surface will be tarmac so in keeping with the rest of the park.

Next financial year we are proposing to replace Fat Mans Reach Bridge with a wider structure and create a 1:20 access ramp onto Broom Hill. These are still in early stages and are yet to be finalised. We will consult on this separately when further details are available

I would appreciate if could forward these plans to anyone who has an interest in Eastville Park and I look forward to receiving your comments, by Monday 10th August, regarding the re-surfacing proposals.

Minutes of the July BPF Meeting

Castle Park

I have now added links to the minutes and other documents relating to the 3 August meeting of the Council's Rights of Way and Greens Committee that considered the Town Green Application to our website.

The committee resolved that:

- i) that the application be rejected for the reasons set out in the Inspector's Report dated 30th March 2009; and
- ii) that the Committee requests that the Council Executive consider bringing forward proposals for Castle Park to be voluntarily made a Town Green as per the 2006 Act, as part of any future development proposals.
- iii) that any development proposal for the St Mary Le Port site aimed to reduce the footprint, so protecting open space in Castle Park.
- iv) that the Council Executive bring forward plans to protect Bristol's valued parks and open spaces by including a programme of voluntary Town Green applications as part of its Parks and Green Spaces Strategy.

### VOLUNTARY REGISTRATION

Can a landowner now voluntarily register land as a green?

Yes. A significant new power in section 15 for the first time enables the owner of land to apply to register it voluntarily as a green. This can only be done if the landowner has first obtained the consent of any lease or charge holder of the land, such as a tenant, or a mortgagee. The owner will need to apply to the registration authority using the new application form to complete the

registration.

Is it necessary for a landowner to sign a statutory declaration if he is voluntarily registering his land?

Yes. This ensures that the person seeking to register his land as a green has provided a sworn or affirmed legal statement to the effect that he is the landowner and, if relevant, that any lessees or chargees have consented to the registration of the land.

What rights will the public have to use greens that have been voluntarily registered?

In Defra's view, a green that has been registered voluntarily will be subject to the same statutory protections as all other registered greens and local people will have the legal right to indulge in sports and pastimes over the green.

Another issue that was mentioned in the meeting, and is referred to in the statement from Daniel Bennett, is that if Castle Park is a formal park held under the Open Spaces Act 1906 then some of the events that have been held on Castle Park (such as the recent 'Ladyboys of Bangkok') may have been unlawful. This of course raises issues for events in other parks which involve fencing off parts of the park. No doubt this is something Parks' Events Officer will be able to clarify when we talk about events at our meeting in October.

The Northern Slopes are also in the area covered by the Knowle West Development Framework.
