BPF Meeting 28th June

The minutes from Saturday's meeting will be available later on our website and distributed by email as usual. Below are a couple of updates on the main issues discussed.

-----

### Grounds Maintenance

The Bristol Parks proposals to bring the grounds maintenance 'in-house' for at least 2 years from March 2015 were agreed at the Cabinet meeting on Tuesday (1st July).

You may also have seen the media coverage of this. It started with what was a reasonably accurate article (with lots of quotes from the Cabinet report) in The Post but with a completely misleading front page and introduction.

The BBC then seem to have believed the Post's headlines and not bothered to check the facts.

As discussed at our meeting the plans are for the grounds maintenance work to be brought back in-house which will give more flexibility to change specifications and priorities.

Neighbourhood Partnerships and Park Groups will have more say in what is done in our parks and park groups or others will be able to do more in their parks to improve them if they wish. We will continue the discussions started with Bristol Parks at the meeting about the mechanics of this.

Bristol City Council / Bristol Parks have made no references to volunteers cutting grass and there are NO PLANS FOR THAT TO HAPPEN.

Core maintenance will continue to be carried out by the current in-house teams and contractors until February. The Contractors' employees who work on the Bristol contracts will then transfer to BCC via the TUPE process and will then be employed directly.

The Labour group amendment to this year's budget delayed the proposed £1/2m budget cut to the Grounds Maintenance budget by 12 months to 2015/16. The proposed cut is 8.5% of the existing net budget of £5.9m. (The actual cost of Grounds Maintenance is £7.3m part of which is covered by income so the actual cut is a slightly lower percentage than this; the figures are in the Cabinet Report). As such Bristol could be said to have got off lightly compared to other core cities, however, cuts on this scale will have an impact. Prior to the 2015/16 budget being finalised in February, the BPF committee will be arguing that the year in which Bristol is Green Capital is not the time to make these cuts.

## Green Capital Project

I'm sorry I missed what was described as an inspiring presentation by Sam Thomson about the ideas for projects for Green Capital.

Sam is putting together a website with the details of the proposals and I will send out the links and add them to our website when they are ready which should be within the next couple of weeks.

There is also a lot of work going on behind the scenes to make sure that all those involved in Green Capital are aware of these ideas and that they fit in with what other people are doing.

The Green Capital Partnership Nature Group, which is co-chaired by Fraser, is meeting next week (11th July).

## State of UK Public Parks

Sarah Royal and Dave Morris of the National Federation of Parks and Green Spaces [www.natfedparks.org.uk](http://www.natfedparks.org.uk) (of which BPF are a member), said about the report:

"This report on the alarming long-term crisis being caused by the underfunding of the UK's parks, so vital to every local community, is a shocking wake-up call which clearly necessitates immediate and effective national action.

The inspirational rise of the Friends Groups movement over the last 15 years has demonstrated the commitment of the public. We are now demanding an equivalent commitment from the Government to ensure adequate public resources for all green spaces, a statutory duty to manage these spaces to decent (Green Flag Awards) standards, and a national inquiry into these matters.

We will be responding to the report by launching a UK-wide public petition, and are also calling on all park users to back Love Parks Week at the end of July to demonstrate our love for our vital local green spaces."

Elizabeth Shaw Chocolate Factory

The redevelopment of this site caused some discussion at our meetings a few years ago when 'cycle homes' were proposed that would effectively use part of the green space of the railway path as their front gardens.

That development stopped due to the recession and the factory has been vacant and unused since then.

There are now revised plans being put together by a different developer Generator South West LLP and they have held workshop sessions with local people.

You may remember that at our meeting in April we mentioned that one of the projects 'ParkWork Bristol' that Fraser had submitted for funding from Rethinking Parks had got to the second stage.

I am delighted to now be able to tell you that the project has been selected as one of only eleven around the country to win funding.

Fraser will now be working with Bristol Parks and the other partners to develop the detail of the scheme.

Rethinking Parks is a partnership between the Big Lottery Fund, Heritage Lottery Fund and Nesta.

## Green Capital Project

In my last update I mentioned that Sam Thomson was putting together a website for the Green Capital Project that she has been pulling together.

Sam has done a tremendous amount of work on this including conversations with lots of different people to try and bring in everyone's ideas and the website is very impressive.

This is very much a work in progress and Sam needs input from from BPF members to inform the next stages & 'shape' of the project from here. Sam has set up a form at [www.bit.ly/1kIvYZo](http://www.bit.ly/1kIvYZo) which she would like groups to complete by by the end of 27th July, to give her a chance to start planning dates/activities etc in more detail.

In terms of funding Sam says:

At the BPF meeting, I confirmed that the parts of this project being resourced by UWE are agreed & 'ready to go' as part of UWE's commitment to support Bristol Green Capital 2015 (and this is a substantial resource which will enable us to achieve a lot of the aims/strands of work), but the involvement of a number of the community-based partners e.g KWMC, Ujima Radio, The Restore Trust etc is contingent on sponsorship being secured through Bristol 2015 to enable them to take part. I am really hopeful that we will be able to secure this funding as I think that the potential for the project in supporting the Green Capital aims is enormous, as well as enabling much more visibility for parks and green spaces in the city with the potential future benefits that this may bring in terms of finances which can support maintenance and improvement of these crucial assets for residents (and visitors).

Crucially for BPF members - in terms of the programme of skills development workshops for parks groups volunteers - 90% of this can be delivered through UWE's resource & commitment to the project, so I am confident that we are not raising aspirations unreasonably at this point & happy to promote this activity now.

## Managing Nature Reserves

One of the concerns that has been raised with Neighbourhood Partnerships having more say in the management of green spaces is that those making decisions might not understand the aims and objectives of nature conservation and might make decisions that are detrimental to nature reserves or other wildlife spaces including areas of grassland.

In order to address this the following proposal has been put forward and passed to Richard Fletcher. I would be particularly interested on the views of those groups involved with Nature Reserves on these ideas.

The Nature Reserves in Bristol require different management/maintenance from that of the more formal parks.

When the NPs decide on an overall plan of management for the parks in their area, this may not be suitable for a nature reserve.

Will the NP be able to stipulate specific requirements for each individual nature reserve?

Can we be assured that there will be the specialist knowledge with each NP, which has nature reserves, to ensure that appropriate maintenance is carried out?

Many community groups have now a long experience of work on reserves and it is in the interests of nature conservation in Bristol that this should continue. Much of the work done has been on the advice of the ecologists employed by Bristol City Council. There has been a decline in the number employed to do this work e.g. the untimely death of the Woodlands and Wildlife Officer.

### Proposals

1) Each NP should agree that the recommendations contained in Management Plans for each individual reserve should be adhered to.

2) Where a management plan does not exist steps should be taken to write them. In the interim professional advice should be sought for guidance as to best practice.

3) A panel of experts could be set up to advise on nature conservation practice. There is a wealth of expert naturalists within the city. We have Bristol Naturalists Society, The Wildlife Trust, City Museum, BRERC, TCV and two universities which teach biological sciences and ecology, also many naturalists both employed and retired from BBC wildlife unit.

It would be a shame in a city which is acknowledged as a wildlife centre that its nature reserves were left to unqualified inexperienced people.

It was from such groups that a precedent was established 35 years ago to advise on Geological Conservation and site selection for conservation. Such a group might be established to play a similar role with regard to ecological conservation.

It is urged that Bristol Parks should take action to ensure that the nature reserves are given the care that is essential to their effective role as sites of conservation.

### Grass Cutting

In the case of reserves, it is important that this is done at the right time vis a vis the type of meadow, the antecedent weather and the ripening of flower seeds. It has been the case in some years that the "needs" of the contractors takes precedence over ecologically based best practice. In house

work should prevent this in future.

There is also the problem that unnecessary cutting takes place "to make it look tidy". Park keepers have not always been appraised of management plans.

Many areas which are grassed open space with an assumption that there is not much ecological value in the grass, however, as was shown in selected parts of the Downs , when the cutting regime was changed (at the suggestion of Helen Hall ) many wild flowers appeared. I would suggest a review of all open spaces in order to assess whether they need such frequent cutting. This would save money and increase the biodiversity in the city.

#### FoN Magpie Bottom

There are Festival of Nature events on The Downs and at Narroways this coming weekend. Then on 20th July there is a 'Nature Open Day' at Magpie Bottom. Magpie Bottom is somewhere that we don't mention very often and it is perhaps one of Bristol's least known green spaces. Magpie Bottom is actually owned by South Gloucestershire Council and they maintain it, but around half of it is within the City of Bristol (in St George). It is a wonderful space either side of the Stradbroom that forms Bristol's eastern boundary with Hanham and is well worth a visit.

## Arts Heritage and Culture Call for Ideas

The Arts Heritage and Culture [AHC] Group is one of the Green Capital Partnerships 'thematic groups' - the Nature group co-chaired by Fraser is another.

The AHC group are looking for proposals for projects from artists, art producers, companies, or individuals working in any art form, AHC will link the best of these proposals with the targeted action group and other appropriate partners. The proposals should respond to and address one or more of the thematic groups' vision statements, and/or Green Capital objectives.

The main criteria for selection is:

- Working in partnership with at least one organisation/community or group (please name a specific group and the level of their involvement if possible)
- Identify the long term impact of the project (Young people and communities outside the centre are a priority)
- Identify the scale of the project, this maybe an intimate experience for a small group or a city wide audience.
- Ideas need to enable 'change', that ask people to imagine the future - for their lives, for Bristol and beyond as the changing climate impacts on the world.
- Ideas should be achievable by December 2015.
- Applications are welcome from outside Bristol and the SW. Its not essential you live in this area.

## Funding

Funding for Green Capital has recently been announced, with three strands (full details can be found on our website <http://artsheritageandculture.org/>)

Our offer is to work with the selected applicants and their proposals to secure funds to enable the project to take place.

Each proposal will be separately funded and realization will depend on securing monies. Apart from Bristol 2015 funding we will also consider Arts Council England, businesses and other sources within each action group.

Discovering Brislington Brook

The Pageant is planned to coincide with St Anne's day and to recreate the medieval pilgrimages to St Anne's Well, which was one of the most important holy sites in Bristol. The well was visited by Henry VII shortly after the battle of Bosworth. Seventeen years later his queen Elizabeth of York visited apparently because it was thought that the holy water would help her conceive; within a year she had given birth to Prince Arthur.

These are the final events organised by Rowan Matthiessen as part of the excellent Discover Brislington Brook Project which has run for the last three years.

Town Greens

The Public Rights of Way and Greens Committee agreed to declare Higham Street Green, Totterdown as a Town Green at its meeting on Monday.

The committee also agreed to accept an amendment to the area applied for as a Town Green at Ashton Vale. This allows the compromise reached between the applicants and the landowners to proceed. The landowners have promised to voluntarily register a further small area to the east of the former tip. The southern part of the site has of course already been registered. The amendment to the application area means that the former tip will not be registered.

## Council Meeting

There were two items on the agenda of yesterday's Full Council meeting that were of particular significance for Bristol's parks.

First the Site Allocations document was finally adopted, this gives most parks and many other open spaces additional protection in planning terms as they are shown as Important Open Space.

The Council also unanimously supported a motion on Parks for Public Use, the motion states:

Council notes the closure of the entirety of Castle Park for the 'Love Saves the Day' event for a week during May 2014, following similar closures in previous years. In addition, we note the substantial damage caused to the park by this year's event.

Whilst recognising that events such as this provide a source of revenue, Council believes that the complete closure of a park in this way for a commercial event is contrary to the principle that the Bristol's parks should be available for use by all of the city's residents.

Council therefore requests the Mayor to:

- i) Ensure that, where events are to be held in the city's parks, this does not result in the closure of the entire park;
- ii) To, where appropriate, work with promoters of 'Love Saves the Day' and other events to find alternative, more appropriate locations within the city for such events;
- iii) To instruct officers to ensure that, where park closures are being considered, the ward councillors are notified as far in advance as possible of the closure.
