The Downs' 150th Anniversary Celebration Picnic

BCC press release:

Everyone in the city is invited to join in celebrations marking The Downs' 150th anniversary on Sunday, May 22.

A special Victorian-themed picnic event has been organised by the city council, The Downs Committee and its partners, including: the Friends of The Downs and Avon Gorge; The Avon Gorge and Downs Wildlife Project and Bristol Rotary Clubs.

On the day, the celebrations run from 12noon to 6pm and entry is free. Visitors are invited to bring a picnic and dress up in Victorian costume. Food stalls and The Downs café will be offering a range of quality refreshments.

In addition, there will be live theatre performance by members of Bristol Old Vic Theatre School, a military encampment with the 95th Rifles, traditional funfair games such as test of strength, coconut shy and treasure hunt. There will also be photoboards and wildlife walks and talks. Throughout the afternoon a range of fun craft activities and historic storytelling will be available in the children's marquee.

The City of Bristol Brass Band and the Madding Crowd with Bristol Harmony choir will perform at intervals during the special Downs' celebration event.

"This is a once in a lifetime celebration," says Vicky Abel, project development officer at the city council. "And we want the whole of Bristol to come along and join in the celebrations.

"The Downs play a very special role in the cultural and environmental life of the city. And over the years, The Downs have become a place for people to get together and have fun. It could be a football match, people out walking the dog, children flying a kite or fun runners raising hundreds of pounds for charity.

"The celebrations marking the 150th anniversary of the signing of the Downs are a chance for us all to say 'thank you' to those who have looked after - and continue to look after - The Downs and ensure The

Downs remain a green jewel in the city's crown."

Jack Penrose, chairman of Friends of The Downs and Avon Gorge (FODAG), added: "The Friends are passionate about The Downs and keen to welcome new members. FODAG are delighted with the programme of activities to mark this special day and proud to be a part of the celebrations.

"There's a good mix of historical, environmental and cultural activities on offer, so I'm sure the day will be a great success."

#### A message from Peter Watts of the Site Licensing Team

Now we have the Royal Wedding Street Parties behind us (did you know Bristol held the most street parties outside of London?) we thought it would be a good idea to contact you to establish whether you are wishing to hold an event again this year and to provide you with some useful information.

We now have a comprehensive website <http://www.bristol.gov.uk/ccm/navigation/leisure-and-culture/events/> where you can download the various application forms:

The Park Permit is aimed at events that are:

- \* Small not-for-profit community events
- \* Taking place outside the city centre
- \* Not advertised to the general public
- \* Expecting fewer than 200 people attending your event (including event 'staff') at any one time

- \* Not specifically aimed at children or vulnerable adults
- \* Not commercially-driven or marketing events

The full site licensing application form is for those larger events that don't fall within a park permit.

Please be aware that at this time of year (peak event season) a minimum 6 week lead in time to assess, consult and issue a licence is required, although for larger events we shall need more notice than this.

The Events Toolkit includes the full application form and other necessary documents to complete when requesting the use of a park or open space. Please refer to the checklist to ensure you have completed all the necessary sections as omissions can create delays.

The most common omissions when completing a form are:

- \* STEWARDS - please advise the number of staff working on your event to make it safe.
- \* LOST CHILDREN STEWARD details - ALL events with children attending must have at least 1 Lost Children steward who has been CRB checked within the last 6 months.
- \* RISK ASSESSMENT - failure to supply a risk assessment will result in your application being refused.
- \* SITE MAP - Please supply a map showing the location of your event
- \* FIRST AID - please advise your first aid provision on the day.

Please note the office is closed every Wednesday from 12 noon to 5pm to process site applications and issue site licences. Staff will therefore be unable to answer telephone calls or deal with personal callers.

If you wish to apply to hold an event on city council open space or in a park please e-mail your application and accompanying documents to [p.watts@bristol.gov.uk](mailto:p.watts@bristol.gov.uk) . Please remember the minimum six week notice as there are a range of consultees that need to be consulted on any application.

Bid Details:

In December 2010 the Government launched a National Tree Planting Campaign the 'Big Tree Plant', which aims to plant a million trees over 4 years. The campaign is focused on community based tree planting in streets, school grounds and other publicly accessible green spaces.

The Forest of Avon Trust is working in partnership with TreeBristol (Bristol City Council), the Woodland Trust and Trees for Cities, to prepare a grant bid as part of the Big Tree Plant to increase tree planting across the city. The focus is on areas of lower tree cover and higher deprivation but all areas can be included. The bid is due to be submitted in August so we are on a tight timescale.

We are working with community groups and interested individuals throughout Bristol so get in touch if you want to work with us to increase tree planting in your area - on streets, green spaces or anywhere in your neighbourhood where the public will benefit.  
We also require match funding so any suggestions would be welcomed.

### The Future of the P&GSS

At the Full Council meeting on 17 May 2011 (following the May elections where the LibDems lost overall control of the Council) Cllr Janke, who was elected as Leader, outlined a number of issues that were agreed by all parties. This included halting all disposals under the Green Spaces Strategy and setting up a cross-party working group to look again at the strategy. The working group once it is established is to set its own terms of reference, so at the moment we don't know how it will work. Of course since no disposals were planned to happen immediately then in the short term halting the disposals does not make any difference.

### Town Green Update - Ashton Vale & Whitchurch

Another item agreed by the LibDems as part of the political negotiations after the election was that there would be an early decision on the Town Green application for Ashton Vale. This is likely to be considered by the Public Rights of Way and Greens Committee at their meeting on 16th June. They can either make the decision themselves or refer the issue to the Full Council.

Meanwhile the Inspector has issued her report on the application at Whitchurch 'Asda Field'. The concluding statement in her summary says:

'I was satisfied that the rest of the amended application land (the whole of the amended application land, with the exception of the former site of the prefabs) had been used by a significant number of inhabitants of the locality of Whitchurch Ecclesiastical Parish for lawful sports and pastimes as of right throughout the relevant period. I therefore recommend that this area should be registered as a town or village green.'

In due course the Public Rights of Way and Greens Committee will make the final decision.

One of the key issues at Whitchurch was whether the land was used 'as of right' or 'by right'. This is an issue which will also be key to several other applications which are now in progress. The inspector sets out in the report how the law relates to this. In particular 'The Council is a creature of statute and can only hold land under its statutory powers to do so'. So the key issue is why the Council owns the land and whether that has changed since the land was purchased. The Council has powers to hold land for open space purposes or for housing; planning (development) or many other purposes. It also has power to appropriate land from one statutory purpose to another.

The respect of land held for open space purposes the inspector said:

'In my judgment therefore, where it is established that the local inhabitants do enjoy a statutory right under section 10 of the Open Spaces Act 1906 or section 164 of the Public Health Act 1875 to use

the land for lawful sports and pastimes, a registration authority should not find that their user has been use "as of right", and accordingly should not find that the statutory test for registration as a town or village green has been satisfied in relation to that land.'

So if the land is held for the purposes of open space it cannot become a Town Green, however, in the case of Whitchurch the inspector has concluded that part of the land was held for planning (development) and part for housing and that there is no evidence that it has ever been appropriated for any other purpose.

'I was not persuaded that any part of the application land was held for open spaces purposes or for public walks and pleasure grounds during the relevant period. In my judgment the fact that an authority uses land held for another statutory purpose to provide a recreational area does not prevent use of that area being use as of right. Similarly I am not satisfied that the fact that land is held under Housing Act powers and laid out as recreation grounds or open space prevents use of that area by local inhabitants being use as of right. Even if I am wrong on that point as a matter of law, on the facts here, I am not satisfied that the area held for housing purposes, the site of the former prefabs, had been in any way laid out as recreation grounds or open space: this area was merely a cleared site.

There was no evidence to show that use had been forcible, permissive or secretive. I therefore conclude that the local inhabitants used the application land throughout the relevant period, as of right.'

The report does though have an appendix that refers to a recent court case 'BDW Trading Ltd (t/a Barratt Homes) v Spooner representing the Merton Green Action Group & Melin Homes Ltd'. In that case it was concluded that 'the provisions of section 241 of the Town and Country Planning Act 1990 prevailed over the Commons Act 2006, so that, the land having been appropriated for planning purposes by the council, it could be used, notwithstanding the Commons Act 2006, by any person in any manner in accordance with planning permission'. The implication of this case is that the land held for planning purposes could be developed even if it is declared as a Town Green, though it is not a reason for it not to be registered. In the Merton Green case the planning permission predated the Town Green application.

There is another paragraph in the report that might be relevant to Ashton Vale as well as Whitchurch, the inspector points out that:

'The Court of Appeal held that the Registration Authority's duty is to decide the application reasonably and fairly. The duty to act reasonably requires the authority to bear in mind that its decision carries legal consequences. The registration authority has to consider both the interests of the landowner and the possible interest of the local inhabitants. That means that there should not be any presumption in favour of registration or any presumption against registration. If the authority accepts the application, amendment of the register may have a significant effect on the owner of the land. Likewise, if the authority wrongly rejects the application, the rights of the applicant and of local inhabitants will not receive the protection intended by Parliament.'
