Bristol Parks have applied for a Charter Mark and members of some Park Groups have been invited to meet the assessor to talk about how Bristol Parks interacts with Park Groups. Hugh Holden, Vice-Chair BPF, would like to be able to report to the assessor the views of those groups who aren't at this meeting, as this could perhaps be a matter of some controversy. In the near future we will also be consulted on the proposed restructuring of Bristol Parks. main points from any comments you send us now will be used at that meeting to start the debate.

### Bus Rapid Transit Latest - Malago threatened?

While the threat to the Railway Path appears to be receding, the Kingfisher Group have been having a close look at other parts of the new Bus Rapid Transit project. They are particularly concerned about the proposal for the route from Hengrove / Hartcliffe to the city centre, as it impacts heavily on the Malago green corridor. The proposal is to actually pave over the Malago at Malago Vale and also build the pavement through the Cotswold Road green space, which are the spaces the Kingfisher Group looks after.

The group are trying to mount a campaign similar to the one that opposed the Bristol-Bath cycle path route and would be pleased to hear from anyone who shares their concerns and/or can offer help. ### Area Green Space Plans

Those of you who were at the last BPF meeting will have seen Richard Fletcher's slide giving the timetable for this process. This has altered since the last Forum meeting. Now a public consultation will take place on each AGSP in turn rather than one for the south and one for the north of the city. #### Malago threat update

#### Wildlife in Parks

I hope you all enjoyed the Festival of Nature. Before the Festival we received an email asking what the Parks Forums views are concerning wildlife habitat in Bristol parks? Hugh replied saying that many of our groups play an active role in encouraging/ creating habitats in their parks and green spaces and that BPF as a whole is obviously very supportive of any efforts in this direction. In fact looking through the mailing list about half of the park groups represent Nature Reserves rather than traditional parks. If you would like to encourage more wildlife into your parks then I'm sure that Bristol Parks' Natural Environment Team would be pleased to help. Part of that team is Sally Oldfield who runs the Nature in the City Project based on some of the Nature Reserves. It is this project that the P&GSS promises to roll out to more sites.
