Ashton Vale and the Stadium (Bristol Planning Application Number 09/02242/P)

The Ashton Vale Heritage Group thanked the BPF for their support.

The planning committee to decide on the stadium, housing etc. is on 4th November (Wednesday) when the council decision will be made. All the groups opposed are meeting on College Green at 5:15 on that day. It is important to show councillors the strength of the opposition. This will also influence the North Somerset Councillors when they come to make their decision on the application for the access

If you can attend then the group would be pleased to see you, you don't have to stay for the meeting, a good turn out will make a difference.

You can also support the campaign to save the Green Belt and Site of Nature Conservation Interest by writing to the committee; the deadline is noon on 3<sup>rd</sup> November (Tuesday). AVHG also stated that they have made an application for Town Green status for the site and the meeting agreed that the BPF should support this.

### Parks Events

The main part of Saturday's meeting was a workshop session on parks events. This was aimed at giving BPF members a chance to give ideas on how the Events Licensing procedure could be improved to make it easier for Park Groups to hold events on their parks. A key part of this is a review of the fees that are charged and discussion as to how Park Groups can access some of the £15k that BCC allocate to funding events. There was also good news on insurance, there will be a new insurance policy for community events which will allow organisers to obtain the necessary £5million of Public Liability Insurance for only £5 per event.

Several BPF members volunteered to join a working group to work with Jenny Crook from the Licensing team to take the process forward.

The aim is for it to be much easier next year for groups to hold small events in their own parks.
Wild City
I was pleased that the meeting agreed that the BPF should write to support this funding application; see <a href="https://www.bristolparksforum.org.uk/#wild">www.bristolparksforum.org.uk/#wild</a>
Operations Update
Rob Thurston (Parks Operations Manager) introduced himself to the BPF having joined Bristol Parks in June.
Rob updated us on progress with the tender process for the Central Area. Roland will represent the BPF in the interviews with prospective contractors that are now due next week.
There was also a review of the South Contract with Quadron, on which there seemed to be mixed views over its success.
Rob confirmed that 9 new Community Park Keepers would be appointed with a target date of February 2010; see <a href="https://www.bristolparksforum.org.uk/#cpk">www.bristolparksforum.org.uk/#cpk</a>
Parks are also in the process of appointing five Apprentices / Trainees
In respect of CPOs there were mixed comments from the floor about their contact with Park Groups, but the general message seemed to be that they have too much to do and not enough time to do it.

Bus Rapid Transit / Knowle West / South Bristol Link
Gary Hopkins confirmed that the Malago route is not being considered as an option for the BRT. However concerns remain, particularly for the Northern Slopes. There was also discussion about the links between all the different developments planned in South Bristol and how these fit in with the Area Green Space Plan process and the BDF work.
Castle Park
Fraser thanked those who had donated money to the fund towards a judicial review of the Town Green decision. A proposal for a more sustainable development of the site has recently been published; see <a href="https://www.bristolparksforum.org.uk/#castle">www.bristolparksforum.org.uk/#castle</a>
Tree Forum

Hugh asked that BPF members should get involved in the Bristol Tree Forum which is putting together a tree strategy for Bristol. The next meeting is Monday 16 November at the Council House. #### Ashton Vale

As you will probably have heard the planning committee followed the officer's advice on the stadium and said that they were 'minded to approve' the stadium but rejected the housing on the Site of Nature Conservation Interest which they had called 'Southlands'.

The football club now have to revise their application and bring it back to the committee within six months.

The rejection of the housing should mean that the SNCI is now safe from development, but there was immediately suggestions that part of the site could be used for an arena. There would also still a need to use part of the SNCI area for flood alleviation. Steve Micklewright from AWT was quoted in the EP as saying that the stadium should come and talk to the AWT about the ecology and wildlife issues.

### **BDF** Core Strategy

The version of the strategy that is to be put to the Council Meeting on 10 November was published online just before the stadium planning meeting at <a href="http://tinyurl.com/bdfcore">http://tinyurl.com/bdfcore</a>

This document is the Publication Version of the Core Strategy. It is the version that the council proposes to submit to the Secretary of State for independent examination under the terms of the Planning and Compulsory Purchase Act 2004.

It includes lots of statements about protection of green space, it also gives a figure of 30,000 new homes in Bristol instead of the 36,500 suggested by the proposed changes to the RSS. These are new homes required in the period covered by the strategy which is 2006 to 2026. Interestingly it also gives some figures for the current situation. Completed dwellings for 2006 to 31 March 2009 were 7,037. Sites with planning permission or agreed subject s.106 are 12,510 leaving 10,453 to be found.

The key policies on green space state:

A network of valuable open spaces, green infrastructure and wildlife habitats will be maintained and improved throughout the city.

- Green Belt areas on the city fringes will be maintained to safeguard Bristol's attractive setting.
- Green infrastructure will be built into new developments across the city.
- Open spaces available to all will be improved.

### Policy BCS9

The integrity and connectivity of the strategic green infrastructure network will be maintained, protected and enhanced. Opportunities to extend the coverage and connectivity of the existing strategic green infrastructure network should be taken.

Individual green assets should be retained wherever possible and integrated into new development. Where loss of green infrastructure is unavoidable in order to secure appropriate development, appropriate mitigation of the lost assets will be required.

Development should incorporate new and / or enhanced green infrastructure of an appropriate type, standard and size. Where on-site provision of green infrastructure is not possible, contributions will be sought to make appropriate provision for green infrastructure off site.

#### Open Space

Open spaces which are important for recreation, leisure and community use, townscape and landscape quality and visual amenity will be protected.

Some areas of open space may be released for appropriate development where:

- They are no longer important for recreation, leisure and community use, townscape and landscape quality and visual amenity;
- Development of all or part of an open space would result in improved urban form or an enhancement to existing open space areas.

New development should incorporate, or contribute towards, the provision of an appropriate level and quality of open space.

#### Biological and Geological Conservation

Internationally important nature conservation sites are subject to statutory protection. National and local sites of biological and geological conservation importance will be protected

having regard to the hierarchy of designations and the potential for appropriate mitigation. The extent to which a development would contribute to the achievement of wider objectives of the Core Strategy will be carefully considered when assessing their impact on biological and geological conservation.

# Good News on Town Green Application

The Elmtree Park Residents' Association has made some progress with their Town Green Application for the 15 acres of land behind Asda in Oatlands Avenue. The inspector's report has concluded that the area that the land has never been appropriated to public open space, and is therefore capable of being registered as a town or village green. You may remember that the Castle Park Application was rejected because the inspector decided that there was an 'implied appropriation'. All land owned by a Council must be held for a purpose, it could be for housing, road building, public open space or many other uses. Appropriation is the process where that purpose is officially changed. Land that is held by the Council as public open space cannot become a Town Green (except by a voluntary registration) because it is used 'by right' rather than 'as of right' (i.e. without permission, force or secrecy). Neither Castle Park or the land in Whitchurch were purchased by the Council for use as open space so a key argument for both sites was whether they were appropriated to public open space. Castle Park was purchased 'for the purposes of dealing with war damage'. The inspector concluded that in 1978, when the resolution to use the land as a park was passed, it must have been implicit in that decision that the land was being appropriated to a new statutory purpose. It is on this principle of 'implied appropriation' that the Castle Park User Group is aiming to seek a judicial review.

Groundwork has a national partnership with M&S (we get the profit from the sale of their bags) which supports us to deliver some physical urban space improvement projects, with local communities / neighbourhood groups, which also incorporate some education and awareness work around climate change and the environmental impacts of our actions.

M&S are asking us to put forward some projects for their consideration, by mid December. They will fund 16 from across the country. In the South West region they are actively seeking appropriate projects from the Bristol / Gloucester M5 corridor area.

What we are looking for...

- A physical transformation / improvement of a publicly accessible space (What do I mean by 'public'? Could I go there and eat my lunch?). Something for families and community use.

The space could be a community garden, a play area (preference for natural play), a wildspace, a pocket park, an urban centre space, country parks, sea front improvements, streetscapes & squares etc. A neighbourhood, community, voluntary or tenants group who would be happy to work with Groundwork to deliver the project (more information about who we are and what we do can be found at www.groundworksouthwest.org.uk. We do have an office in Bristol and staff who would be happy to discuss any opportunities further.

- A project with a total cost of approx. £50,000.
- M&S would provide up to £25,000 for the space transformation work.
- A project with the rest of the match funding already in place, or likely to be in place within a few weeks.
- A site where the landowner has given permission for the project to proceed and planning permission is not required (or has already been obtained or is likely to be approved within a few weeks).
- A group who are happy to work with us on awareness of environmental issues, our impacts on climate change and the actions that we can take. This is important to M&S and should be interesting not onerous!
- Opportunities for M&S staff (and maybe even customers) to get involved.
- Project sites should be within 10 miles from an M&S store.
- Projects that will have an impact. Projects that will make a difference for the people who live / work / play there.
- Projects which can be completed by no later than 1st December 2010.

At this stage we are not looking to develop entirely new projects. We are looking for an existing project which is at the right stage of development and happens to fit these criteria. Please feel free to circulate this information to anyone you think might be appropriate and if anyone has any suggestions or questions, please ask them to contact me, my colleague Julie Winkley our Development Manager (julie.winkley@groundwork.org.uk 01752 217721 ext 334) or Jane Hickie our Operations Manager for the West of England (jane.hickie@groundwork.org.uk 0117 971 5719).

This is to confirm that the Network has agreed with City Council officers the following series of involvement meetings in the choice of route, stops and engineering necessary for the Council to submit a bid to the Department of Transport for this scheme to be placed in the "programme" list. The Council's target deadline for submission is 31st March 2010.

Unlike the community involvement in Line 2 Ashton Gate to City Centre, this involvement will include choices of the route.

The community involvement programme looks like this:

Meeting 1 (Agenda: Purpose of BRT/cost-benefit criteria to be applied/reduction of route options/involvement issues)
Friday 27 November 2009

Meeting 2 (Agenda: Route/stop/engineering options) Wednesday 9th December 2009

Public consultation period (Agenda yet to be decided) 2nd to 23rd December 2009

Meeting 3 (Agenda: Preferred route/stop/engineering option) Wednesday 13th January 2010

There is talk of extending the public consultation period over Christmas/New Year. We have said that we doubt the public relations benefit of this. From a community point of view this would look disdainful of the community's right and ability to engage properly.

We have also said that it is important to be up-front and clear about the involvement process, especially at the first meeting on the 27th. That agenda should include an explanation/discussion of how the involvement meetings tie into and have a chance of influencing the BCC/West of England Partnership/Department of Transport approvals process.

All meetings will be at 17.30 for 1800 to 2000 at the Park Centre, Daventry Road, Knowle West.

As with Line 2, the idea is to assemble one or two reps from each Group so as to keep the meetings effective in numbers and enable in-depth discussion. We are asking reps to check back on the views of their wider group. The consultation period will also check wider public views.

The BPF committee have seen a copy of an email that Peter sent to all Bristol Parks staff on Wednesday which I feel should be shared with all BPF members, especially as it is clear from my inbox that rumours about this news are starting to spread.

"Dear colleagues,

I am writing to let you know that I have been working under an extended probationary period since I was appointed as Service Manager for Parks and Estates in June.

I am very sorry to have to tell you that at my review meeting yesterday afternoon, Tracey Morgan informed me that my performance did not meet her standards nor apparently those of the Executive Member. She therefore had to inform me that I was not confirmed in my post, and would therefore (I am assuming) go into redeployment.

I know this will come as a huge shock to most of you, but for me I was expecting this and it comes as a relief after a very difficult couple of months.

Tracey will let you know as soon as she can what arrangements she will now put in place to lead and manage Parks and Estates."

Tracey Morgan is 'Service Director, Environment & Leisure' having taken over in this post from Steve Moore who left at the end of October.

Obviously this came as a shock to us since we (along with Parks' staff) had had no prior indication of any problem. Peter has been head of Parks for as long as I have been involved with the BPF and has always been very honest and open with us. Fraser is arranging a meeting with Tracey for later this week to discuss the situation. In email discussions Tracey has said that 'we will continue to work with you [BPF] as we have always done'.

We have also contacted Cllr Gary Hopkins both he and Tracey have stated that the only planned changes to the Parks structure are the appointment of additional Community Park Keepers. Tracey

added 'I am however looking at how we can improve the services within Environment and Leisure and once I have clear ideas on this, I would be more than happy to share this with the BPF'.

I will let you know any further developments as they occur. In the meantime I'm sure you will join me in wishing Peter all the best for the future whether that lies at Bristol City Council or elsewhere.

#### 29 November 2009

Meeting with Tracey Morgan

Here is Fraser's summary of the meeting we had with Tracey Morgan:

On Thursday evening Rob, Hugh and myself met with Tracey Morgan, the service director for environment and leisure. We had requested the meeting as members of Bristol Parks Forum had raised concerns over the continuing role of the Parks Forum as a result of the departure of Peter Wilkinson from his post. Concerns had also been raised that a large amount of knowledge and experience would be lost given Peter's departure.

We did have a constructive session with Tracey and the following points summarise the main areas of discussion.

- \* Tracey sees no change in the way that the Parks Forum works with Bristol Parks. She will present at the next forum meeting in January to share the work that has been undertaken over the last few months.
- \* Steve Moore worked in tandem with Tracey from the end of August until he left to affect the handover of the service director role.
- \* She is keen to see that what is working within Parks continues to do so and her focus will be on areas where improvement is required.
- \* Her priorities are the renewal of the central contract, completion of the area green space plans and improvement in the delivery of services.
- \* Tracey's recent background is with integrated Customer Services.

We also took the opportunity to highlight concerns we had over the timetable for the area green space plan consultation and the impact of the community infrastructure levy on the parks and green spaces strategy. We will have further discussions on these with Tracey and Gary Hopkins over the next month.

BRT - North Bristol to Hengrove

Bristol City Council have launched a consultation on their website about the Bendy Bus route from North Bristol to Hengrove. The consultation includes a questionnaire and some public exhibitions.

In October we were told that there were now only two options for South Bristol but there now seem to be four. There are also proposals for a Park & Ride on small holdings between the M32 and Stapleton Rd which will also impact the allotments in that area.

Unfortunately none of the websites say anything about what the routes affect in terms of houses, buildings, landscapes, wildlife etc.

Not surprisingly; the Northern Slopes Initiative <a href="www.northern-slopes-initiative.co.uk">www.northern-slopes-initiative.co.uk</a> are very concerned. The effects on the Slopes could be extremely significant, if a route goes across their area potentially splitting the area in to four parts, rather than the current three. The risk of further development on either side of the route must also increase if a route across the slopes goes ahead, and value of the land either side for environmental reasons goes down.

There are also concerns about the Hartcliffe Way options and their impact on the Pigeonhouse stream although as promised the Malago seems to be safe.
