### Bristol Town Green Consultation

Following on from the national consultation on Town Greens, Bristol City Council are running their own consultation on the process used to determine Town Green applications.

This follows the withdrawal of proposals for a change which were made at the Public Rights of Way and Greens committee in April. The new proposals are similar but the word 'Occasionally' has been removed from the description of when an application should be referred to a public enquiry.

Full Council Meeting

As expected today's Full Council Meeting decided to defer the decision on disposal of 49 spaces for the Neighbourhood Committees to decide. Note, it will be the Neighbourhood Committees, not the Neighbourhood Partnerships that make the decisions.

Our main concern was that with the threat of changes to national planning policy and the Government's talk about selling off public assets then the process shouldn't be allowed to delay the Site Allocations document. We have been told that the Neighbourhood Committees will be asked to make their decisions by the end of January.

Filwood TG Application

The second inspector's report on the application for Town Green Status at Filwood Park has now been produced. It recommends that Town Green status shouldn't be granted. The key paragraphs are 17 & 18:

[17] At a meeting of the full council on 14th May 1985 the council considered a report of the Resources and Co-ordination Committee. Part V of that report recommended additional proposed schemes for inclusion in the Capital Programme for 1985/86. Appendix B to the report listed the schemes which included £20,000 expenditure on Filwood Park. The full council resolved to accept Part V of the report and to approve and adopt the recommendations. It therefore appears that on 14th May 1985 the full council approved capital expenditure of £20,000 on Filwood Park to improve it as a park.

[18] It appears to me that this resolution must have effected an implied appropriation of Filwood Park to public park purposes under s. 164 of the PHA 1875 for the reasons explained in para. 139 of my earlier report. It follows that recreational use of Filwood Park after 1985 was not "as of right" but "by right". This is fatal to the town green application.

The inspector explains more about why he considers this to be an implied appropriation later in the report, it answer to the points raised by the applicants:

[23] The first thread is a submission that there would be no illegality in the full council's authorising expenditure on Filwood Park as a public park without appropriating the land to open space purposes. I do not accept this submission. If the site of Filwood Park was held for education (or airport or housing) purposes, it seems to me that the council would be acting outside its statutory powers in authorising capital expenditure on Filwood Park as a public park. If a council holds land for one statutory purpose, I consider that its duty is to spend council money on the land for that purpose and for no other purposes.

If you have a project in your park that you want to fund then talk to your Area Environment Officer (see above) as a starting point. If your project needs some Section 106 money (perhaps as match funding) then you will have to talk to your Neighbourhood Partnership, but they do not otherwise need to get involved so long as your project does not conflict with anything in the Green Space

Investment Plan for your area.

NPs & Disposals

Following the Full Council meeting we are awaiting details of how the process for Neighbourhood Partnerships to decide on disposals will work. It is likely following the debate that the 'incentive' system will change. It is also not yet clear whether the principle of NPs making the decision on land disposals will apply in Knowle West which has so far been excluded from the process.

It is worth remembering that there is still a lot of pressure from central government for Councils to sell assets and also to get more houses built. Whatever process NPs use to make decisions needs to be something that can't be challenged later if spaces are to be protected. It is also important that all

retained green space gets listed as important green space in the Site Allocations document.

Community Infrastructure Levy (CIL) Consultation

The figures in the Cross Party Working Group report were on the basis of 27% of the proposed CIL (that will partly replace S106) would go to Parks with £10.5m being raised by 2026. Bristol City Council have now launched a consultation on the introduction of CIL. The consultation seems to suggest that only 20% of CIL would go to local communities with 80% going to 'strategic infrastructure projects'. That would seem to suggest that Parks will get a much lower figure than predicted.

From the Strategic Planning Team:

Bristol City Council is moving forward with the introduction of a Community Infrastructure Levy (CIL) for Bristol. At the same time we are amending our Planning Obligations SPD in order that both CIL and our revised Planning Obligations policies are implemented simultaneously.

A Revision to SPD4 (Planning Obligations)
