£2,500 needed for Castle Park Appeal

A message from the Castle Park Users Group:

Please help us to preserve Castle Park by making it a town green. We recently submitted a town green application to the council which went to inquiry. We met all the criteria but one. Our barrister firmly believes that the inspectors decision on that point is wrong in law and that we should appeal. He believes that we have a strong case and a good chance of winning. His opinion is supported by our legal advisor who has taken other such cases to review. Given this, we have decided to take the decision to judicial review.

The judicial review will of course cost money. Some of this is expected to covered by legal aid but we need to raise £2,500.

Please give us your support through the purchase of bonds to help pay for the judicial review and ask your friends to do the same. If we win our case and our costs we will refund them to you if you claim it back from us after the final legal decision within six months. Please give what you can afford.

Wild City Consultation

As I mentioned in an earlier email, Bristol Parks are bidding to Natural England for Access to Nature funding for a new project to be called Wild City. The project aims to build on the huge

success of the Nature in the City project which was run by Sally Oldfield as Local Nature Reserves Officer. The project will fund one (or maybe two) Local Nature Reserve Officers.

Ashton Vale and the BDF

The first week of November is going to be busy for planners. The planning committee meeting to discuss the application to build the stadium (and associated housing etc) on Green Belt land (Bristol Planning Application Number 09/02242/P) will be on 4 November. The application to build a Tesco store on the current stadium site (09/03208/P) will then be considered on 5 November.

The North Somerset ref for the stadium is 09/P/1061/F2 - it is worth looking at their website (see <http://tinyurl.com/yle22gg>) since they publish comments as they are submitted. Objections received by North Somerset so far include those from the Environment Agency and the Avon Wildlife Trust. The statement submitted to Bristol CC by the BPF (as agreed at our last meeting) can be seen here: www.bristolparksforum.org.uk/BPFAshtonValeSNCI.pdf

In the meantime the BDF Core Strategy which will include a policy on 'Green Infrastructure' and (in the absence of the RSS) will set the target number houses to built in Bristol before 2026 will go to a meeting of the full Council for approval on 10 November. Papers for that meeting will be published on 2 November and so the proposed document will be made public just before the planning meetings on Ashton Vale.

As you know, there have been a series of community involvement sessions in which Park Groups have taken part, the last of which was in September. We have been told that 'the team working on the core strategy has used the notes from the meeting to continue to refine the emerging Core Strategy, in particular the policies for Green Infrastructure, Housing Provision and Green Belt'.

The planning application for the South West Urban extension 'Ashton Park' is also now under consideration by officers at both Bristol City and North Somerset - see <http://www.bristol.gov.uk/swbue> Again the North Somerset allows you to see the objections already submitted; no doubt they would also publish comments in favour if there were any!

The next meeting of the Bristol Parks Forum will be on Saturday 31st October 9.30am at Windmill Hill City Farm, Philip Street, Bedminster, Bristol.

As you can see it is a very full agenda, but hopefully there will still be time in the AOB section for some issues to be raised from the floor. Ashton Vale may well be one of these – see below.

It is also our AGM – as I mentioned before we would like to have at least one committee member from south Bristol and ideally one from each of the four operational areas. If you are willing to stand please speak to Fraser during the meeting.

The Parks Events Workshop stems from discussions we had with Parks earlier in the year about why Park Groups should pay fees for events and why the licensing process is so complex for even the smallest events. Jennifer Crook in the Events team has reacted very positively to what we said and the workshop is aimed at developing a way to make it easier for groups to hold events. It will also look at the way Parks events budget is spent and is a chance for BPF members to have a say in planning events for 2010.

Ashton Vale - Planning Application 09/02242/P

The application for the new stadium, housing on Ashton Vale SNCI and various other buildings and facilities will be considered by the Development Control (South & East) Committee on Wed 4 November at 6pm in a committee room in the Council House. The officers report and recommendation will appear on the BCC website www.bristol.gov.uk/meetings from tomorrow (Wednesday).

The Ashton Vale Group are also asking that the BPF make a statement to the meeting.

The Avon Wildlife Trust has sent the following message to its members:

Please will you help the Trust to halt plans for a football stadium at Ashton Vale and so save an important and legally-protected wildlife site from destruction?

We don't want to stop Bristol getting a new football stadium; we know that many people are excited at the prospect of the city becoming a World Cup venue (some of our own staff, supporters and family members among them!). Our objection stems solely from a belief that Ashton Vale is entirely the wrong place to choose - for these main reasons:

1. Ashton Vale benefits from very strong protection because of its conservation value – if it can't be protected, where can be?
2. The development will destroy the homes, feeding and breeding grounds of many wild animals, including rare ones, such as bats, otters, wading birds and water voles.
3. Granting permission will set a planning precedent, making it much harder for the council to defend other green spaces from development.

There are plenty of other places in Bristol for a stadium. The same isn't true for wildlife in an a bustling city. So, please, stand up for wildlife! Urge the council to think again.

Bendy Bus Routes
