Morning presentations

Making the most of community involvement
Fraser Bridgeford, Bristol Parks Forum

Community groups and volunteers play an invaluable role in the management of our green spaces. Fraser Bridgeford explains the origins of the Bristol Parks Forum and how it actively supports Bristol City Council, focusing on their work to influence decision-makers, improve the profile of the city's parks, and protect investment, revenue and resources.

What support is available for community groups in developing public spaces?
Nicola Mathers, CABE Space

Help and assistance for community groups involved in the management of open spaces is essential if projects are to be successful. Nicola Mathers will outline some of the support mechanisms that are available to volunteer groups who are involved in the planning, design and ongoing management of public spaces.

Improving the sustainability of your project
Lynn Gibbons, Sustainability South West

It is vital that community projects are developed sustainably if they are to be truly successful. Lynn Gibbons will provide an overview of some of the initiatives available to community group which can ensure decision making is based on proven sustainability criteria and thus contribute towards making the South West a more sustainable region.

The benefits of Green Infrastructure to communities
Roger Gates, GreenSpace South West

Green Infrastructure (GI) is the natural environment network that lies within and links our cities, towns and villages. This presentation will introduce the concept of GI and explore some of the social and environmental benefits that can be realised by community groups, volunteers and visitors to green spaces.

Afternoon Workshops

How community groups can play a greater role in the management of green spaces?
Nicola Mathers, Adviser, CABE Space

The enthusiasm, commitment and local knowledge within a community are invaluable qualities when it comes to establishing volunteer groups to successfully manage open spaces. However, community groups can encounter many unfamiliar processes and practices that can appear overly bureaucratic when wanting to improve a public space. Nicola Mathers will outline some of the options available to groups to enable them to become more empowered, by looking at case studies and providing an overview of free guides and resources available to community groups.

Toolkits for sustainable community management of open spaces
Lynn Gibbons, Project Manager, Sustainability South West

Every individual, group or organisation can take steps to be more sustainable. However it can be challenging to know where to start in terms of assessing your project and then deciding on the best course of action to reduce your carbon footprint. Lynn Gibbons will demonstrate the new SustNav sustainability toolkit and other initiatives which will provide a simple sustainability assessment of your project or proposed scheme. It will enable you to start thinking about integrating sustainability measures into your project.

We are also aiming to hold some other workshops specifically looking at:

- 1) Fundraising; and
- 2) Help for community groups when starting up.

Once any additions/amendments to the programme are confirmed, the final programme will be announced.

Events, Park Permits

After the last workshop session with the Events team I mentioned that a new Parks Permit scheme was to be introduced to make it easier to license small events. Unfortunately the Safety Advisory Group for Events have insisted that this should only apply to events with less than 100 people expected and not specifically aimed at children. They also say that the event shouldn't be advertised to the general public.

The application form for these Permits is now on the website, though it is not easy to find. Despite the fact that these are Park Permits they are on the Leisure & Arts section of the website rather than the Parks website as you might expect.

The best place to start is www.bristol.gov.uk/ccm/navigation/leisure-and-culture/events You can then see links to 'Parks Permits' and to the 'Event Site License Application Toolkit'. If you follow the link to 'Event Site Licensing' you will also see details of monthly Briefing Sessions that have been set up for events organisers. If you are planning events for next year these would be well

worth attending, unfortunately they are all day time sessions so no good for those of us who work.

Ashton Vale Town Green Application

Area Green Space Plan Consultation

The criteria on which the recreational value of sites is assessed are set out in Appendix 5 of the P&GSS. It can be seen at www.bristolparksforum.org.uk/PGSSApp5.pdf If you wish to object to a space being assessed as low value then the best way is to say why the site is not low value against these criteria. The final decisions on disposals will be made by Cabinet probably in December.

A map showing the 2008 quantity of space per person from the CD version of the P&GSS is here: www.bristolparksforum.org.uk/Citywide_Quantity.pdf There should not be any disposals in areas with less public green space than the Bristol standard of 18m²/person. Some spaces in Ashley, Easton and Lawrence have been assessed as low value but the AGSP says they will not be sold off unless a development can provide an alternative space.

This is your chance to have a say on the future of your park for the next 20 years so you should make the most of it.

Alison's quick summary:

"These are the bit of policy that the 'development management' officers - [previously called 'development control' officers] use to decide whether to approve or refuse planning applications. So it is important that they are written so that rogue developers and lawyers can't wriggle out of them and that they cover all the things that are important to us."

BPF Meeting 9 Oct 2010

The minutes of yesterday's meeting will be sent out by Catherine in due course. There were some interesting discussions on Neighbourhood Partnerships, Parks Organisation and of course Area Green Space Plans.

Hugh was elected as Chair of BPF, he can only serve for one year having been chair for two years previously. Fraser is now Vice Chair and Mary from Castle Park Users Group has joined myself, Alison, Roland and Nancy as the other committee members.

One of the first jobs for the new committee is to agree meeting dates for 2011, I will let you know once we have fixed them. We also aim to have two committee meetings between each of the main meetings.

Knowle West Regeneration Framework

Consultation on the proposals for Knowle West starts officially on 13 October and will be on the web at www.bristol.gov.uk/kwrf

These proposals fill the hole in the Area Green Space Space Plan for that area and so this will be the first chance for people living there and in the surrounding areas to see how the green space standards will be met in their area. The consultation is currently planned to run for only two weeks. At the request of the Northern Slopes Initiative at the meeting the BPF will be asking for this to be extended by at least two weeks.

An additional drop in session to look at the AGSP proposals for the whole of Filwood, Knowle and Windmill Hill will be held on Monday 18 Oct at The Park Local Opportunity Centre, Daventry Road, Bristol BS4 1DQ The session will run from midday to 8pm. So this will be a chance to see how the Regeneration Framework proposals fit with the AGSP.

Unfortunately there is still a hole in the plans for this area because the consultation will apparently still not cover the proposals for the Kindswear & Torpoint development. You can find out more at <http://www.northern-slopes-initiative.co.uk>

Parks Reorganisation

At the meeting Tracey Morgan shared the outline of the new structure which will go to consultation with staff over the next month. Tracey had also had discussions with the BPF committee about this. We think the new proposals are promising and we are pleased the Tracey is listening to what we and her staff are saying.

Clifton Camp conservation project

This proposed work on the Downs might be of interest.

Students from Ashton Park School will carry out a geo-survey of part of the Iron Age camp that surrounds the Clifton Observatory, from 9.30am, Monday 11 October.

The buried archaeology of Clifton Camp has not been surveyed in modern times - or with sophisticated equipment. The lucky students will be hands-on with archaeologist Tony Roberts to use the machinery, upload data onto an on-site computer and get some instant results. Tony, of Archeoscan, will be on hand to interpret the data.

The geo-survey launches a week of guided walks and an exhibition (18-23 Oct) to show the public what Bristol City Council will be doing to conserve the Scheduled Ancient Monument for future generations of people and wildlife.

The week of events, activities and exhibits will demonstrate how the council is starting work this winter to gradually remove selected vegetation through careful phasing of scrub clearance over the next five to ten years. The council is obliged to manage and maintain this important Iron Age site and is carrying out the work in partnership with English Heritage and wildlife consultants.

AGSP Consultation, Closing Date 29 October

Less than two weeks left on the consultation!

The last drop in session is in Knowle West on Monday (18 Oct) at The Park Local Opportunity Centre, Daventry Road, Bristol BS4 1DQ The session will run from midday to 8pm. The options for development in Knowle West are now on the Council's website at www.bristol.gov.uk/kwrf These cover the area that is greyed out in the AGSP. Displays at the drop in session will show how the options fit with the AGSP process.

AGSP report on disposals to Cabinet and Scrutiny

Parks officers are drawing up a report to scrutiny commission and cabinet to guide their decision on disposal of low amenity value green space. All responses will be attached to the report so that councillors can see the original documents. The report will highlight particular issues on the following criteria:

- a.. volume of response about a particular park [eg petitions etc]
- b.. any particular response/issue that appeared a large number of times
- c.. any response that gave rise to a change of assessment about whether a site was low amenity value.

Scrutiny Commission meets on 6th December and cabinet on 12th December. The report can be changed to reflect scrutiny commission responses before the document is finalised for cabinet consideration.

If a group is has canvassed local community opinion before submitting a response for their park, it would be a good idea to tell the Parks Officers how they have done this, so that the officers can be aware of the strength of support for the response. A Community Involvement Statement would be the best way of doing this - setting out the methods the group has used eg mail drops/ email circulars / meetings and the number of people who responded and whose point of view has been used to guide the group response.

Knowle West Consultation Extended to 12 November.

Paul Owens has emailed to say 'Further to representation made at the Bristol Parks Forum meeting, and representations made at the Filwood/Knowle/Windmill Hill Neighbourhood Partnership meeting on 12th October, the current phase of the Knowle West Regeneration Plan consultation is being extended by two weeks, and will now end on 12th November 2010'.

The request for an extension was also supported by the Avon Wildlife Trust who are concerned about the possible impact on the Sites of Nature Conservation Interest in the area.

Note the proposed development at Kingswear Road & Torpoint is not included in this consultation,

so we still don't have a full picture of all the impacts on green space in Knowle West. Yet another separate consultation is planned for that area!
